In line with 360 Capital REIT's (ASX:TOT) refined strategy, TOT has acquired a 50.0% interest in PMG Funds, a leading NZ based real estate fund manager with over NZ\$6651 million of real estate Funds Under Management ("FUM").

The NZ\$17.5 million equity partnership has been structured as cash of NZ\$13.3 million and a potential earn-out of NZ\$4.2 million over a period of two years based on key financial milestones.

The partnership gives TOT exposure to a growing funds management platform across New Zealand and access to on ground management expertise to enable TOT to invest in direct commercial and industrial real estate transactions in New Zealand. Furthermore, TOT will support the growth of the PMG's funds management platform through an underwriting facility at market rates.

As part of the transaction, TOT has committed to a NZ\$10 million underwriting position for the acquisition of NZ\$108.1 million of commercial and industrial assets across New Zealand for one of PMG's funds.
