Transurban Sharelink Incentive Scheme – Summary

The Transurban Holdings Limited Sharelink Incentive Scheme (**Scheme**) allows eligible employees to acquire stapled securities of the Transurban Group (**stapled securities**).

Under the Scheme, employees may elect to receive stapled securities up to the value of \$1,000 at no cost to the employee.

Stapled Securities Acquired Under the Scheme

Stapled securities acquired by the participants will be fully paid, rank equally with existing stapled securities and be subject to any restrictions or other conditions determined by the Board. Stapled securities acquired under the Scheme have the same rights as other stapled securities, including voting rights and rights to receive distributions.

Restrictions

A stapled security provided to a participant under the Scheme will be a restricted stapled security until the earlier of 3 years after the date it is acquired and the participant ceasing to be an employee. A participant must not dispose of any stapled securities acquired under the Scheme while they are restricted.

When a stapled security ceases to be a restricted stapled security, all restrictions on dealing with that security provided in or under the Scheme rules will cease. Dealings will continue to be subject to the Transurban Dealing in Securities Policy.

Change in Control and Reconstructions

If a change in control of Transurban Group occurs, the restrictions applying to restricted stapled securities will be deemed to be waived. If a restructure event occurs, the Board may, at its discretion, waive any restrictions applying to restricted stapled securities.

Forfeiture

If in the Board's opinion a participant acts fraudulently or dishonestly or is in breach of their obligations to any Transurban Group entity, the Board may at its discretion deem the participant to have forfeited any right or interest in the stapled securities or any other entitlements under the Scheme in relation to those stapled securities.
