#### **Results of Extraordinary General Meeting**

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth) (Corporations Act), Freedom Foods Group Limited (ASX:FNP) (Company) is pleased to announce all thirteen resolutions put to shareholders at the Extraordinary General Meeting of the Company held on 25 May 2021 (EGM), were duly passed.

By passing these resolutions:

- the Notes issued to Arrovest under the Placement and to current and former Directors and other professional and sophisticated investors under the Wholesale Investor Offer are capable of being converted into Shares and will not be cash-settled; and
- the Company will proceed with its intended issue of listed Options to eligible shareholders. The Options are not a pro-rata offer within the meaning of the ASX Listing Rules, accordingly the timetable set out in Appendix 7A will not apply. Further details in relation to the Options will be set out in a prospectus, expected to be lodged with ASIC and ASX on 1 June 2021.

All resolutions put to shareholders at the EGM were decided by way of poll.
