Indiana's Executive Chairman Bronwyn Barnes said:

"I am pleased to see shareholders continuing to exercise their options and convert to shares in advance of their expiry. As the Company ramps up its exploration activities in South Australia these funds will immediately support our planned programmes, which have delivered extraordinarily successful results to date. The Board has maintained its position to not undertake a placement in the short term as funds to be received by the Company, if all listed options are exercised prior to their expiry date of 5th August 2021 will total more than \$3.9 million. These funds will be more than sufficient to support our current planned exploration activity, with sufficient funds to follow up results as they are delivered."
