## Swoop Holdings Limited – (ASX: SWP) – Formerly Stemify Limited – Anticipated Reinstatement to Official Quotation

### Description

The securities of Swoop Holdings Limited ('SWP') are expected to be reinstated to Official Quotation at the commencement of trading at 10:09:00 am AEST on Thursday, 27 May 2021, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. SWP raised A\$20,000,000 pursuant to the offer under its prospectus dated 16 April 2021 ('Prospectus') and its supplementary prospectus dated 7 May 2021 (the 'Supplementary Prospectus') by the issue of 40,000,000 shares at an issue price of A\$0.50 per share.
