BEAM RECEIVES NEW ORDERS FOR ZOLEO DEVICES

Highlights:

- Beam receives orders for 22,000 ZOLEO devices
- New order is expected to be invoiced and shipped by December 2021
- The order will ensure the joint venture can meet consumer demand ahead of busy North American summer season, as well as Christmas and Australian summer holidays
- 5,500 of this order earmarked for Australia and New Zealand as Australia Post gears up to sell
 ZOLEO and Beam prepares to enter NZ market in July
- Total orders to date for ZOLEO stand at ~69,000 units

Beam Communications Holdings Ltd (ASX: BCC) is pleased to announce that it has received its seventh and largest order to-date of the multi-award winning ZOLEO device.

The new order for 22,000 ZOLEO devices from its 50%-owned joint venture entity, ZOLEO Inc., is expected to be invoiced and shipped by December 2021 and will ensure that both Roadpost Inc. and BCC will have sufficient inventory to meet growing consumer demand heading into the busy North American summer season, Christmas and the Australian summer.

Of this total order, 5,500 of the devices are earmarked to support the momentum in the Australian and New Zealand markets, especially as Australia Post Group gears up to sell ZOLEO at selected outlets and online from its website later this month and Beam prepares to launch the product in New Zealand in July.

The total number of devices ordered from Beam to date now stands at 69,245 units.

Further, Beam continues to receive multiple direct and repeat orders for ZOLEO from Anaconda Group Pty Ltd and Telstra's largest satellite dealer and Beam's subsidiary, SatPhone Shop.
