Chairman Retirement

The Company announces that Mr Richard Anderson will retire as Board Chairman and Non-executive Director and will not seek re-election to the Board. Mr Anderson's retirement will be effective 31 August 2021.

Mr Anderson joined the Board of the Company in December of 2002, during that time Mr Anderson fulfilled roles as Chairman of the Audit and risk Committee, and more recently as Chairman of the Board of Directors.
