Shona Croucher – Chief Financial Officer biography

Shona has broad finance and governance experience. At Bellamy's she held the position of CFO and more recently, Director of Finance and People, where she was responsible for key governance and finance outcomes as well as reporting and financial management of Group's international subsidiaries. She was previously a director of all subsidiary entities of the Bellamy's Group. In her dual role as Director of Finance and People, she was also responsible for HR governance and reporting to the Board's remuneration committee.
