**Key terms of the Standby Convertible note facility**

The credit standby arrangements relates to an original \$2 million facility with a cornerstone shareholder investor Mr John Plummer.

On 19 August 2019, the Group reduced and extended its previous convertible note loan facility provided by Mr Plummer on new and more favourable terms.

The key terms of the new facility are:

Note extended to 1 August 2021 for drawdown;

Line fee reduced to 1% pa (from 2% pa);

Interest rate of RBA Cash Rate plus 8.5% pa, therefore currently 8.6% per annum, payable quarterly in arrears;

Agreement to renegotiate interest rate further downwards following the Company achieving a cash flow breakeven quarter and an additional rate reduction on delivering three consecutive cash flow positive quarters;

Usual covenants for a facility of this nature and scope including: unsecured obligation, no debt subordination without consent, anti-dilution provisions etc.; and

Facility can be repaid in full or reduced at any time at the election of the Company.

On 19 August 2019, \$1.3 million of the previous convertible note facility was repaid from recent capital raise funds, leaving \$0.6 million drawn and \$1.4 million undrawn and available.

The Company received a further draw of \$350k in October 2019, \$350k in November 2019 and \$250k in December 2019 before the successful capital raise, resulting in a balance of \$1,550k drawn and \$450k undrawn.

In December 2020, the Company withdrew \$450k of the note, leaving \$2m drawn.

Given the company's growth prospects and progress, cornerstone shareholder Mr John Plummer agreed in January 2021 to increase the current convertible loan facility which represents a low cost of capital, on the same terms, from \$2m to \$4m and extended to August 2022. The Board appreciates John's ongoing support for 1st Group.

In February and March 2021, the company withdrew \$300k and \$150k respectively.

In April and May 2021, the company withdrew \$200k, and another \$400k was drawn down in June 2021.

Between July 2021 and September 2021, the company withdrew a total of \$550k in three batches.

Mr Plummer has extended repayments arising from the facility to 28 October 2022.

Answer: Net operating cash outflow is expected to reduce from current levels as contracted sources of revenue growth are realised.

Answer: An entitlement offer in September 2021 raised approximately \$1.3m (before costs), which has settled into our bank account.

Answer: Yes. Based on net outflows expected to reduce in coming quarters, proceeds from the capital raising and further sources of funding expected to be available if they are needed.
