## Settlement of the Buy-Back and Rights Issue and suspension from trade

Redcape Hotel Group Management Ltd as the responsible entity of the Redcape Hotel Group (ASX:RDC) ("Redcape" or the "Group") announces completion of the Buy-Back and Rights Issue undertaken as part of Redcape's delisting and Redcape's suspension from quotation as confirmed today by the ASX.

Redcape's Directors Net Asset Value is expected to increase to \$1.34 per security at 31 October 2021<sup>1</sup> as a result of an earlier than forecast resumption of trade, prudent cost management throughout the lockdown period and Redcape's Buy-Back of 100.0 million securities.

Redcape's delisting is expected to take effect from 2 November 2021.
