Further to its recent announcement of ETIX Everywhere exchanging on 1.2MW data centre in Nantes, Global Data Centre Group (**GDC**) is pleased to announce the following updates in relation to its Guam Data Centre (**Guam**) investment.

#### Guam Data Centre

The board of Gateway Network Connections (GNC) which owns and operates the Guam data centre has approved the fit out of the additional 1.0MW/140 racks capacity to take the data centre to its full capacity of 1.8MW/250 racks. Target completion to finalise the expansion is 9 months.
