Endeavour Group has issued a total of 2,199,260 Performance Rights for its Long Term Incentive (LTI) under the Endeavour Incentive Share Plan. They comprise of:

F22 LTI grant of 1,147,692 Performance Rights; F21 LTI grant of 700,600 Performance Rights; and F20 LTI grant of 350,968 Performance Rights.

The F22 awards will have a performance period of three years. The F20 and F21 awards are replacements for the forfeited portion of grants issued to certain KMP under Woolworths' Long Term Incentive plans at the time of the demerger. The F20 awards will have a performance period of one year and the F21 awards will have a performance period of two years.

The LTI awards set out above were issued on the terms outlined on pages 78-79 and 82-83 in the Remuneration Report of Endeavour's 2021 Annual Report. Each Performance Right is an entitlement to receive one fully paid ordinary share in Endeavour Group Limited, subject to meeting vesting conditions.
