We refer to the Cashrewards Limited (**Cashrewards**) announcement titled "Notice of release of shares subject to voluntary escrow" released on ASX on 12 August 2021 (**Voluntary Escrow Announcement**).

As noted in the Voluntary Escrow Announcement, 18,073,403 fully paid ordinary shares (**Shares**), which became subject to voluntary escrow arrangements at the time that Cashrewards was admitted to the official list of ASX, were released from voluntary escrow at 10:00am on 1 September 2021 (being the next trading day after Cashrewards released its preliminary final report for the full year ended 30 June 2021) (**Voluntary Escrow Release**).
