AMP announces redemption of AMP Capital Notes (ASX: AMPPA)

AMP Limited announces that it will redeem all of its A\$267.5 million AMP Capital Notes (**Notes**) on the optional exchange date which is 22 December 2021 (**Redemption Date**).

In accordance with the Terms of the Notes, AMP may elect to redeem some or all of the Notes on the Redemption Date, subject to prior written approval from the Australian Prudential Regulation Authority (APRA). APRA has provided its prior written approval of the redemption to AMP.

Holders who are on the register of Notes on 14 December 2021 will receive the face value of A\$100.00 per Note plus the final distribution of A\$1.2755 per Note (together, **Redemption Amount**) on the Redemption Date.
