### **JobKeeper Payments Disclosure**

People Infrastructure Ltd (**People Infrastructure**) provides the attached Jobkeeper Payments Notification in accordance with subsection 323DB(1) of the *Corporations Act 2001* (Cth), which was recently introduced by *Treasury Laws Amendment (2021 Measures No. 2) Act 2021 (Act)*.

The Act requires listed entities to notify the market if the listed entity, or a subsidiary of the listed entity, received a JobKeeper payment (within the meaning of the *Coronavirus Economic Response Package (Payments and Benefits) Rules 2020*) during the financial year.

As a result of the JobKeeper support, People Infrastructure was able to make payments to its on-hire workforce who otherwise would not have received wages equivalent to the JobKeeper support (i.e. the payments were completely passed through or paid to clients) and was also able to keep a large number of employees employed who would otherwise have been stood down, made redundant or forced to access other Government unemployment benefits.
