She is currently the Chairman of the Supervisory Board of Marley Spoon A.G., as well as a non-executive director on the boards of Appen Ltd and Pro Medicus Ltd. Deena is also the Chairman of the government's Australian Broadband Advisory Council and is on the board of Opera Australia.

Previous roles include: Chairman of the global board of BAI Communications, and a director on the boards of Infrastructure Australia and Export Finance Australia.

Deena has a B.Sc(Econ) Hons from the London School of Economics and a law degree from the University of Cambridge and is a Fellow of the Australian Institute of Company Directors.
