Endeavour Group has issued 3,743,037 Performance Rights for its Long Term Incentive (LTI) under the Endeavour Incentive Share Plan. They comprise of:

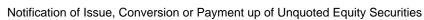
F22 LTI grant of 2,167,534 Performance Rights;

F21 LTI grant of 74,289 Performance Rights;

F21 Transitional LTI grant of 1,120,992 Performance Rights; and

F20 Transitional LTI grant of 380,222 Performance Rights.

The F22 award will have a performance period of three years and the F21 award will have a performance period of two years. The F20 Transitional LTI and F21 Transitional LTI awards are replacements for the forfeited portion of grants issued to certain employees under Woolworths' Long Term Incentive plans at the time of the demerger. The F20 Transitional LTI award will have a performance period of one year and the F21 Transitional LTI award will have a performance Period of two years. Each Performance Right is an entitlement to receive one fully paid ordinary share in Endeavour Group Limited, subject to meeting vesting conditions.


