Shareholder approval for the buy-back was received at the Company's 2019 AGM. Pursuant to the terms of the loan funded share plan, the participant has forfeited their shares and they will be bought back at the initial issue price and the associated loan repaid. The participant is not entitled to any proceeds from the buy back. The shares will then be cancelled. The buyback and cancellation will occur on 12 Jan 2022.
