Appointment of Deborah Page AM as Chair

Sydney, Australia, 17 January 2022 - Pendal Group Limited (ASX: PDL) today announced that Mr James Evans has retired as Chairman of Pendal Group Limited (Pendal Group) with current Director Mrs Deborah Page AM appointed as Chair, effective 17 January 2022.

Mrs Page was appointed as an independent non-executive Director of Pendal Group in April 2014 and has been the Chair of the Audit and Risk Committee since 2016. Mrs Page has extensive experience as a company director and chair across a range of sectors, including funds management, insurance and technology. She is currently a director of ASX listed companies Brickworks Limited, Growthpoint Properties Australia Limited and Service Stream Limited and is a former partner of Touche Ross/KPMG.
