### Appointment of Peter Warne as Chairman

Further to its announcement of 14 October 2021, IPH Limited, the leading intellectual property (IP) services group in the Asia Pacific region, today announced that Chairman-elect, Mr Peter Warne has been appointed Chairman of IPH with effect from today.

Mr Warne was elected Non-Executive Director and Chairman-elect at IPH's Annual General Meeting on 18 November 2021.

Dr Andrew Blattman, CEO and Managing Director of IPH, said: "Richard was instrumental in leading our business from a privately owned professional services firm to its present position as an ASX 200 company with a market capitalisation of approximately \$1.9 billion today.

"Over the same period IPH has conducted 10 strategic acquisitions and our total staff numbers have grown from 300 to over 900. I am grateful to Richard for his personal support and steadfast leadership in helping to create the strong and sustainable business that IPH is today."

#### Peter Warne

Mr Warne was elected to the board of IPH on 18 November 2021. Mr Warne was a director of the Sydney Futures Exchange (SFE) from 1990 to 1999, and from 2000 to 2006. He served as deputy chairman of the SFE from 1995 to 1999. When the SFE merged with the Australian Securities Exchange (ASX Limited) in July 2006, he became a director of ASX Limited, a position he held to 2020.

He has previously served as Chairman of ALE Property Group from 2003 to 2017 and OzForex Group Limited (now trading as OFX Limited) from 2013 to 2016. He was a director of New South Wales Treasury Corporation from 2012 until 2020, where he served as Chairman from 2019 until 2020.

Mr Warne is the chairman of Macquarie Group Limited, a board member of Allens and a member of the ASIC Corporate Governance Consultative Panel.
