Atturra completes Kettering transaction

Key highlights:

- Atturra completes acquisition of Kettering, an ERP solutions provider based in Brisbane, Australia which specialises in the implementation, management, and ongoing support of ERP solutions in the manufacturing sector.
- The completion of the Acquisition follows Atturra's announcement on 17 January 2022.
- The contribution of the Kettering Acquisition is accretive to the prospectus forecast, the Companyexpects that the Acquisition will add incremental revenue of 1.6m and EBIT of 0.18m to the FY22 full-year results and in line with guidance.
- The Acquisition will make Atturra a market leader in QAD ERP solutions in Australia and will increase Atturra's manufacturing client base to over 50.

Sydney, Australia, 1 March 2022: Leading advisory and technology solutions provider Atturra Limited (ASX: ATA) (Atturra) today announced that it has completed the acquisition of Kettering Professional Services Pty Ltd (ACN: 114 612 001) (Kettering) (Acquisition).

Headquartered in Brisbane, Kettering is a specialist enterprise resource planning (ERP) solutions provider with a strong focus on local manufacturing. It implements and manages QAD Inc. (QAD) ERP solutions, providing the full breadth of services in QAD's product range and ecosystem. QAD was founded in 1979 and serves customers in over 100 countries with their manufacturing ERP software. QAD was recently acquired by Thoma Bravo at an equity value of approximately US\$2 billion. Kettering is the sole operating QAD partner in Australia, New Zealand and Fiji.

The purchase price, including upfront consideration of approximately \$3M, and up to \$2.25M in deferred consideration reflects a 4.05 multiple calculated by reference to achieving all of the deferred consideration milestones. The deferred consideration is structured into milestone earnouts for each financial year until FY 2024.

Atturra Chief Executive Officer, Stephen Kowal, said:

"It is great to welcome Kettering to the Atturra business. Kettering is a great fit both strategically and culturally. Atturra is passionate about building sovereign capabilities and ensuring that our clients, whether they are in the public or private sector, have a genuine local option. Atturra will now have over 50 manufacturing clients and is the Australian market leader in QAD services.
