The shares being bought back were issued to a former employee under the Company's Loan Funded Share Plan (LFSP) and are being bought back by the Company under the rules of the LFSP, with the proceeds applied to offset the loan taken out by the employee to acquire the shares. A total of 348,422 shares are being bought back at an average price of \$6.3789 per share, comprising 204,537 shares being bought back at \$6.1644 per share and 143,885 shares being bought back at \$6.6839 per share.
