Amani Gold Limited (ASX: ANL) ("Amani" or "the Company") is pleased to provide a brief update on the operations of the Company.

Repayment of Convertible Note

Amani Gold has undertaken full repayment of all outstanding convertible notes issued to Neo Gold Limited for a total amount of A\$2,191,670.84. The Company issued 2.1M notes with a face value of A\$1 per note, a 2.5% interest rate and a maturity date of 29 January 2022.
