### APPEN BOARD CHANGES AND DIRECTOR ELECTIONS

Appen Ltd (ASX: APX) (Appen) today announced the appointment of Stuart Davis as an independent non-executive Director to the Board. Mr Davis's appointment is effective 29 March 2022. In addition, Ms Deena Shiff has advised that she has decided not to stand for re-election at Appen's upcoming Annual General Meeting (AGM) and will retire from the board following the AGM on 27 May 2022.

Commenting on the appointment of Mr Stuart Davis, Appen's Chair, Mr Richard Freudenstein said, "Stuart is an experienced and highly respected director. He brings extensive expertise and knowledge gained from his 30-year career as an international banker with HSBC Group including roles in Hong Kong, New York, Taiwan, India and Australia.

"Stuart is currently a non-executive Director of NEXTDC Limited, where he is Chair of the Remuneration and Nomination Committee, and a Member of the Audit and Risk Management Committee. He is also a director of PayPal Australia Limited and BSP Financial Group Limited. I look forward to working with Stuart and drawing on his wealth of international experience to deliver value for our shareholders."

Mr Davis will stand for election at Appen's AGM on 27 May 2022.

Commenting on the retirement of Ms Deena Shiff, Appen's Chair, Mr Richard Freudenstein said, "On behalf of my fellow directors, I would like to thank Deena for her valuable contribution to Appen, including as a member of the Audit & Risk Management Committee. She has served as a director since May 2015 and has overseen significant development and progress of Appen's business and leaves the company in a strong position."
