## **ASX Release**

Alliance Aviation Services Limited ("Alliance") (ASX: AQZ)

ACCC not to take enforcement action in relation to 19.9% acquisition of Alliance by Qantas Airways Limited (ASX: QAN)

Alliance Aviation Services Limited (**Alliance** or the **Company**) refers to the ASX announcement dated 1 June 2020 attaching an Australian Competition & Commission (**ACCC**) media release titled "Investigation into Qantas's stake in Alliance Airlines continues".

The ACCC has written to Alliance stating that it does not propose to take any further enforcement action in relation to the stake that Qantas has in Alliance. In its letter, the ACCC states:

"I refer to our previous correspondence regarding the ACCC's investigation of the completed acquisition of a 19.9% shareholding in Alliance Aviation Services Ltd (**Alliance Airlines**) by Qantas Airways Limited (**Qantas**) (the **Acquisition**).

The Australian Competition and Consumer Commission (ACCC) has considered the information it has before it in relation to the Acquisition. Based on the information available to date, the ACCC does not propose to take any further enforcement action at this time pursuant to section 50 of the Competition and Consumer Act 2010.

Although the ACCC is not proposing to take any further enforcement action at this point in time in relation to this matter, it will continue to monitor Qantas's conduct in the industry in relation to Alliance and may take action at a later time."
