Webcentral has sold more than 10,000 new .au domain registrations since the launch of .au on 24 March 2022, a strong start to the launch of the new .au domain.

Webcentral and Melbourne IT manage over 330,000 domain registrations (.com.au or .net.au) that are eligible to secure the new .au domain, the shorter and more Australia domain prefix.

If you hold a .com.au or .net.au domain then you have first right to the .au, but only until September when it will then be open to anyone to register your .au.

Head of Digital Jay Salter said:

"We are excited by the success so far of the launch, much of the investment is in social and online and we have been testing radio and partnering with the St Kilda Football Club. auDA the governing body has also been contributing to expanding the message in the market.

The multi-channel marketing approach has enhanced overall brand awareness and has increased website cart activity."

CloudPort product launch

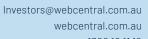
