On 4 March 2021 Xingang Resources (HK) Ltd agreed to extend the term of the existing unsecured loan from 31 December 2021 to 31 December 2025 at an interest rate of 2.5%, with repayment due at maturity of the loan. The original loan of \$4,000,000 plus accrued interest of \$504,650 forms the principal of this loan.

The Company also signed a loan agreement with Rich Mark Development (Group) Pty Ltd on 4 February 2021 for \$4,800,000. The loan is available for drawdown in 6 tranches through to 31 March 2022. The loan is unsecured and subject to interest of 2.5%, which accrues six monthly and is payable along with the principle at maturity and matures on 31 January 2024.

The Company also signed a new loan agreement with Rich Mark Development (Group) Pty Ltd on 19 November 2021 for \$7,500,000. The loan is available for drawdown in 6 tranches through to 31 March 2023. The loan is unsecured and subject to interest of 2.2%, which accrues six monthly and is payable along with the principle at maturity and matures on 30 November 2026. During the current quarter, the Company drew down \$1,500,000 of this loan.
