## Outlook

As announced on 23 May 2022, Perenti expects FY22 revenue of \$2.4 billion and EBIT(A) of between \$170 million and \$175 million.

FY23 guidance will be delivered with the release of our FY22 financial and operational results, however qualitative FY23 guidance includes:

- FY23 EBIT(A) will be stronger than FY22 EBIT(A)
- FY23 capital expenditure will be significantly less when compared to FY22
- FY23 leverage will be well below FY22
- FY23 free cash flows will be stronger than FY22

Mark Norwell, Managing Director and Chief Executive Officer of Perenti said "The last few years has seen Perenti navigate through unprecedented challenges. For us to tighten our FY22 earnings guidance range and present an expectation of lower capital spend but strong growth in earnings and free cash flow into FY23 reflects the strength and resilience of our business but also shows the significant and continued effort and commitment of our 9,000 employees."

The release of our updated 2025 Strategy is designed to deliver enduring value and certainty to our stakeholders in a safe, innovative and sustainable manner. We have a dedicated and committed team focused on delivering our commitments to generate competitive returns for our shareholders."
