360 Capital FM Limited as responsible entity of the 360 Capital Enhanced Income Fund (ASX:TCF) ("TCF" or the "Fund) has commenced a strategic review of the Fund following recent changes to the interest rate environment which we believe will impact the ability to scale the Fund, resulting in poor trading liquidity and continuing discount between the Fund's trading price and its Net Tangible Asset ("NTA") value.

The Fund's last closing price was \$5.00 per unit with an NTA of \$5.94 and it continues to pay a monthly distribution of 3.0 cents per unit equating to a distribution yield of 7.2% per annum based on the last closing price.

The Fund capital is fully deployed, and its loan investments continue to perform and remain within their loan covenants.

The Strategic Review will consider amongst other things, the potential refinancing of the Funds loan investment and a return of capital to unitholders in line with the Fund's NTA.

The result of the Strategic Review is expected to be announced on or before the Fund's FY22 results announcement in August 2022.
