- (a) On 1 July 2022, Enero issued 2,855,607 fully paid ordinary Enero shares at an issue price of \$2.81615 per share (**New Shares**) in connection with the acquisition of GetIT Pte. Ltd and ROI DNA as outlined in Enero's announcement dated 1 July 2022.
- (b) The New Shares were issued without disclosure to the investors under Part 6D.2 of the Act.
