Results of Extraordinary General Meeting

Airtasker Limited (Airtasker or the Company) advises that its extraordinary general meeting of shareholders was held today at 10:00am (EGM).

All resolutions put to shareholders at the EGM were decided on a poll and were successfully passed. In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), the Company provides the attached summary describing the resolutions put to shareholders at the EGM and details of the votes cast, including by validly appointed proxies.

Following the approval of resolutions 2 – 4 for entities controlled by the Company's directors, James Spenceley, Fred Bai and Peter Hammond to participate in the placement announced on 4 May 2022 (Placement), the issue of shares under the Placement to the directors' controlled entities will occur on 19 August 2022.
