The facility is supported by its gas production assets in the Appalachia region of the USA and carries an interest rate of US LIBOR+650bps. Empire made a US\$137,500 debt repayment during the Quarter reducing the outstanding balance from US\$5,712,510 to US\$5,575,010.
