#### LINK GROUP 2022 SCHEME MEETING AND SPECIAL GENERAL MEETING IMPORTANT INFORMATION – NEW MEETING DATES, REVISED SCHEME CONSIDERATION AND NEW PROXY FORMS REQUIRED

Dear Link Group Shareholder,

On 7 July 2022, Link Group sent you a letter advising that Link Group had postponed the Scheme Meeting and the Special General Meeting (the **Meetings**) in connection with the proposed acquisition of Link Group by a wholly owned subsidiary of Dye & Durham Corporation (**D&D**) by way of scheme of arrangement (**Scheme**), to a date to be determined.

On 21 July 2022, following careful consideration and discussions with D&D, Link Group agreed with D&D to reduce the Base Cash Consideration under the Scheme to \$4.81 per share (**Revised Scheme**).

As announced by Link Group to the ASX on 2 August 2022, the Supreme Court of New South Wales has ordered that Link Group convene the postponed Scheme Meeting of Link Group shareholders to consider and vote on the Revised Scheme and despatch a supplementary explanatory booklet to Link Group shareholders.

The postponed Scheme Meeting will be held at **10.00am (Sydney time) on Monday, 22 August 2022**. The postponed Special General Meeting will be held at **10.15am (Sydney time) on Monday, 22 August 2022** or as soon after that time as the Scheme Meeting has concluded or been adjourned.

The Meetings will continue to be held as hybrid meetings. Link Group Shareholders will be able to attend the Meetings in person at Sheraton Grand Sydney Hyde Park Hotel, 161 Elizabeth St, Sydney NSW 2000 or by logging in online at <u>https://meetings.linkgroup.com/LNKSM22</u>.

In the lead up to the Meetings, Link Group will be closely monitoring the changing COVID-19 situation and associated health restrictions. If it becomes necessary or appropriate to make alternative arrangements for the holding of the Meetings, Link Group Shareholders will be given as much notice as possible. Any changes will be advised to the ASX and posted on Link Group's website at <u>www.linkgroup.com</u>.

All Link Group Shareholders registered on the Link Group share register as at 7.00pm (Sydney time) on Saturday, 20 August 2022 will be eligible to vote at the Meetings.
