HMC Funds Management Limited (AFSL 237257) (**RE**) as responsible entity for the HomeCo Daily Needs REIT (**HDN**) (together, the **Group**) provides this Corporate Governance Statement which discloses the extent to which the Group follows the recommendations set by the ASX Corporate Governance Council in its publication "Corporate Governance Principles and Recommendations (the Fourth Edition)", *ASX Corporate Governance Council*, as revised in February 2019 (**Recommendations**). The Recommendations are not prescriptive, but guidelines against which entities have to report on an "if not, why not" basis. HMC IM and HMC PM are wholly owned subsidiaries of Home Consortium Limited (trading as **HMC Capital**).

All matters, unless specifically reserved for the Board, necessary for the day-to-day management of HDN are delegated to the Manager.

The Board's responsibilities are defined in the Board Charter and there is a clear delineation between the function reserved to the Board and those conferred upon the Manager.

In accordance with the Board Charter, the Board has the following specific responsibilities:
