# Change in MAAS Group Holdings Ltd substantial holding and free float analysis

MAAS Group Holdings Limited (ASX: MGH, "the Company" or "MGH") refers to the appended Form 604 (Notice of Change of Interest of Substantial Holder).

The change of interest for MGH arises from the release of securities from voluntary escrow on 19 August 2022 and MGH now no longer having a relevant interest in those securities as MGH no longer has the power to control the disposal of those securities. The voluntary escrow arrangements are in connection with the initial public offering (IPO) of MGH in 2020 and shares issued in relation to various business acquisitions which occurred post IPO.

The information below is also provided to clarify the Company's proportion of shares available for trade on a free float basis ("Free Float").

The Company considers its Free Float to be **37.4%** of total issued capital.

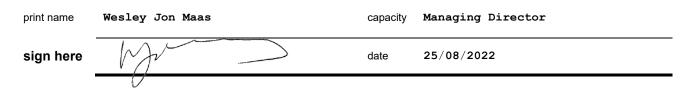
