

Notice under Section 708A(5)(e) of the Corporations Act

On 30 August 2022, Omni Bridgeway Limited (**Omni Bridgeway**) issued 2,768,359 ordinary fully paid shares to the trustee of the Omni Bridgeway Employee Share Trust in satisfaction of vested performance rights.

Omni Bridgeway advises that the Corporations Act 2001 (Cth) (Act) restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or section 708A.
