### Form 604 Correction - Cooper Energy Limited (COE)

L1 Capital Pty Ltd (ABN 21 125 378 145) (L1 Capital) notes that the filing of the "notice of change of interests of a substantial holder" form (Form 604) for COE lodged with the Australian Securities Exchange (ASX) and COE on 15 February 2022 was incomplete.

The Form 604 was incomplete in that it inadvertently omitted the relevant consideration amount of \$6,504,575.00 having been paid to L1 Capital for the sale of 21,086,414 securities.

An amended Form 604 is attached to this letter, which has been lodged for the sole purpose of correcting the previous Form 604.

A copy of the amended Form 604 has also been lodged with COE.

For completeness, L1 Capital notes that its most recent Form 604, which was lodged on 12 September 2022, shows L1 Capital's voting power to be 11.02%.
