QUARTERLEY ACTIVITY STATEMENT TO 30 SEPTEMBER 2022

The Company advises its operational activities for the quarter to 30 September 2022 as follows;

Sea Cucumber Project

The Company wound back its operations and manufacturing in Japan during the quarter to save costs. In the quarter the Company had small sales of its finished product in Japan.

Blue Ocean Japan

Mr Nakamura returned to Australia during the quarter.

Bundybunna

The Company has been negotiating to permit the termination of the liquidation of the Bundybunna Aboriginal Corporation Limited (in liquidation) (BbAC) and the establishment of a long terms lease on part of the land owned by the BbAC in Western Australia. The Company is examining the feasibility of using the land for a carbon credit and/or renewal energy project.

General Investments

Mr Nakamura visited Singapore and discussed various renewal energy projects in which the Company could invest in the future, particularly projects to be undertaken in Japan and Australia.

Corporate

The proposed conversion of the loans arranged in June 2022 previously advised to take place at the Annual General Meeting to be held on 10 November 2022 and referred to in the Activity Statement for the quarter ending 30 June 2022 have been deferred. No conversion date has been determined. Discussions are continuing with Lenders to secure the conversion of the loans to ordinary shares in the Company.
