# Kelsian expands into the education transport sector through the proposed acquisition of Horizons West Bus and Coachlines

## **Key Highlights**

- Kelsian to acquire the business assets of Horizons West Bus and Coachlines ("Horizons West") for an enterprise value of A\$23.4 million<sup>2</sup> plus contingent, deferred consideration and earn-out component of up to A\$7.0 million
- In addition, strategic property assets to be acquired for A\$16.7 million
- Perth based Horizons West owns and operates 138 buses from two strategic depot locations
- Founded in 1985, Horizons West is one of Perth's longest established family owned and operated bus and coach companies providing transport for schools, universities, government, corporates, and tours
- Market leading provider of contracted bus services and bus charter services to the education sector in Western Australia
- Further platform for growth, complementing and enhancing existing Kelsian businesses in Western Australia, and allowing expansion into the adjacent education bus transportation sector in Australia
- Creates a further diversified market leader in Western Australian bus and coach services
- The all cash consideration will be funded from existing cash reserves

Kelsian Group Limited (ASX:KLS) ("**Kelsian**"), advises today it has entered into binding agreements to acquire the assets used in and comprising the business trading as 'Horizons West Bus and Coachlines' ("**Horizons West**") together with ancillary assets from the Vendors<sup>1</sup> for an enterprise value of A\$23.4 million<sup>2</sup> plus a contingent, deferred consideration and earn-out component of up to A\$7.0 million. In addition, Kelsian will purchase strategic property assets<sup>3</sup> comprising two depots for A\$16.7 million (together the '**Acquisition**').

Kelsian will acquire Horizons West through its wholly owned subsidiary WA Bus and Coachlines Pty Ltd, and will acquire the property assets through its wholly owned subsidiary, STG Properties Pty Ltd.

The Acquisition will be funded from existing cash reserves.

The Acquisition is expected to complete in late 2022/early 2023. Completion of the Acquisition is subject to certain conditions precedent standard for transactions of this nature.

Transaction costs of approximately A\$1.6 million are expected to be incurred by Kelsian.

### Overview

Established in 1985, Horizons West has a highly visible brand, and is well recognised in the Perth metropolitan area for bus hire and coach charter services provided to the education sector. Horizons West specialises in providing contracted and charter bus services to schools, universities and government with approximately 157 employees operating a bus fleet of 138 buses from two depots. Horizons West currently operates 21 contracts for the Government of Western Australia and provides services to more than 400 schools and a university.

The key strategic and commercial rationale for the Acquisition include:

- In FY22, Horizons West generated A\$15.9 million in revenue and normalised Earnings Before Interest, Tax, Depreciation and Amortisation of \$5.2 million
- Horizons West's market leading position in the Western Australia education transport sector will complement Kelsian's market leading positions in the public transport and resources sector bus markets in Western Australia
- Expansion across new adjacent sector (education transport) provides a new platform for organic growth in the Australian bus market
- Enhanced end-market diversification for Kelsian
- Additional locations, fleet and labour capacity allowing Kelsian to capitalise on available opportunities in resources, government and tourism sectors in Western Australia
- Existing experienced management team to be retained
- Two strategically located Perth bus depots, one in Welshpool and another in Landsdale, provide a base for high quality bus maintenance and the ability to efficiently service the Perth metropolitan area.

Following the acquisition, Kelsian will operate a portfolio of 1,367 buses and employ 1,982 people in Western Australia through the operating businesses of Swan Transit, Go West Tours and Horizons West. Kelsian's intention is to continue to work with and focus on maintaining existing levels of service for Horizons West clients, as well as welcoming employees of Horizons West into the Kelsian Group.
