Priya has over two decades of experience in product management, marketing and strategy, most recently in digital platforms for global supply chains.

Priya is currently Chief Product Officer for FourKites, a leading logistics technology firm based in Chicago, USA, which provides real-time product visibility supply chain solutions to its global customers. Priya was a founding product leader of FourKites and has led its product and sales growth strategies since 2016.

Priya was named a 2021 Supply Chain Pro to Know and one of the 2021 Women in Supply Chain by *Supply & Demand Chain Executive*, a leading supply chain trade publication. *The Software Report* named her a Top 25 Software Product Executive in 2021 and 2022.
