Alcidion Co-Founder and Executive Director resignation

Melbourne, Australia – Alcidion Group Limited (‘Alcidion’ or the ‘Company’) today advises that Alcidion co-founder Dr Malcolm Pradhan is stepping down as Executive Director and Chief Medical Officer as part of a natural evolution and a well-established succession plan adopted by the board several years ago.

Dr Pradhan has been an architect of the Alcidion business for more than 22 years and has been a visionary, and important contributor, to building the Miya platform that is now well established in hospitals across Australia, New Zealand, and the United Kingdom

With the Alcidion business now firmly in an execution stage and following the acquisition of ExtraMed and SilverLink last year, Dr Pradhan has decided that the timing was now right for him to step away.

Over that last 2-3 years Alcidion has invested in building its capabilities across leadership and the company and is well placed to continue to execute on the product vision laid out by Dr Pradhan. This next phase requires a greater focus on roles directed towards product delivery and execution.

Alcidion Non-Executive Chair Rebecca Wilson said: “Malcolm has made a tremendous contribution to Alcidion. His vision to deliver decision support for clinicians was born two decades ago and he has continued to play an important role in making this vision a reality and providing the strong foundations for our success today and in the future.”

“Our business maturity supports this opportunity for Malcolm to step back from the business knowing that we have a team with the right expertise and experience to support Alcidion’s next phase of expansion.”

“On behalf of the Board, senior executive team and the entire Alcidion team I’d like to thank Malcolm for his commitment and contributions.”

Dr Pradhan added: “I’m incredibly proud of what we’ve achieved at Alcidion, delivering smart, elegant, and easy to use solutions designed to assist clinicians and administrators to solve many of the challenges in the healthcare system based on open standards and interoperability. I take comfort knowing our progress has accelerated over the last few years and I’m leaving at a time of strong leadership and a growing customer footprint.”

Under the ASX Listing Rules, Dr Pradhan was listed for re-election to the Board at the Annual General Meeting (AGM) for 30th November 2022. Dr Pradhan will not be seeking re-election and will now retire as a director (and executive) immediately following the AGM. There will be an announcement from the Company withdrawing the resolution for Dr Pradhan’s nomination as a director to follow.
