AMENDMENT TO APPENDIX 4C

Sydney: All and Medical Technology company Echo IQ (the Company) (ASX:EIQ) provides an amended Appendix 4C that accompanied the original ASX release of the September Quarterly Report lodged on 28 October, 2022.

The amendment includes an update to items 8.5 and 8.6 of the Appendix 4C. Item 8.5 now shows the number of estimated quarters of available funding to be 1.97, instead of 2, inadvertently rounded in the previous release. This rounding resulted in the omission of Item 8.6, now completed in this amendment. Item 8.6 outlines the Company's intention to raise additional funding, as announced in October in the amount of a \$3.5 million capital raise.

No further updates have been made to the Appendix 4C which is attached in full to this release.

Answer: Yes, as announced in October the Company secured \$3.5m in funding via a capital raising. 21,793,333 shares have been issued to sophisticated investors at \$0.15 per share raising \$3.269m with the remaining 1,540,000 shares to be issued to HeartX shortly.
