Results of 2022 AGM

In accordance with ASX Listing Rule 3.13.2 and Section 251AA of the Corporations Act 2001, Alligator Energy Ltd is pleased to advise that all ordinary resolutions tabled at the Company's Annual General Meeting held at 10.00am on Friday 25 November 2022 were passed by means of a poll.

The special resolution in relation to the additional 10% capacity did not pass with two significant Shareholders voting against this motion. The Company plans to engage with these Shareholders to understand their concerns.

Valid proxies were received representing 561.6M shares and their specific voting preferences along with the results of the poll are set out in the attached 'Results of Meeting' template.


