Notice of extension of entitlement offer

Energy World Corporation Limited (ASX:**EWC**) (**Energy World** or the **Company**) advises that it has extended the closing date for its pro-rata non-renounceable entitlement offer (**Entitlement Offer**).

On 24 November 2022, the Company announced a pro rata non-renounceable entitlement offer of 1 new fully paid ordinary share (**New Share**) for every 2.39 existing shares held by eligible holders on the Record Date at an issue price of \$0.05 per New Share, to raise up to \$54.5 million (before costs), along with an attaching option issued on the basis of 1 free-attaching option for every 10 New Shares subscribed for under the Entitlement Offer. Each option has an exercise price of \$0.12 and expiry date 2 years from the date of issue.

The closing date of the Entitlement Offer has been extended from 5.00pm (AEDT) 15 December 2022 until 5.00pm (AEDT) 22 December 2022.
