On 12 Dec 2022, 682 Rights were issued to a participant in connection with the demerger of Sierra Rutile Holdings Limited from Iluka, as disclosed in section 3.25 of the Demerger Booklet listed above.

During Q4 2022, 663,772 Rights, each being a right to receive a fully paid ordinary share in Iluka on satisfaction of vesting Conditions, were issued. The relevant Rights were issued pursuant to Iluka's umbrella Equity Incentive Plan ("EIP") Rules. Vesting is subject to performance and continued employment, and the vesting conditions will be tested in 2024 (one-third) and 2025 (two-thirds). The other material terms of the issue are consistent with terms of the 2022 EIP, details of which are available in the Remuneration Report contained in Iluka's 2021 Annual Report.

On 13 Dec 2022, 47,189 Rights were granted to a newly recruited member of Iluka's management team pursuant to the EIP, consisting of service rights and performance rights.
