QUARTERLY ACTIVITY REPORT AND APPENDIX 4C

4DS Memory Limited (ASX:4DS) (**4DS**) (the **Company**), is pleased to provide its Quarterly Activity Report and Appendix 4C for the Quarter ended 31 December 2022.

Company Update

On 5 October 2022, 4DS announced it had completed its analysis and has identified the modified etch process as the most likely cause of the poor electrical performance of the memory cells used in the imec megabit memory array. Please review that announcement for more detail.

In line with the 2022 agreement with imec, the Company concluded discussions with imec to make modifications to the manufacturing of another Platform Lot.

The goal of this next Platform Lot remains the demonstration of the cell operation in a megabit memory array environment and to explore optimized programming conditions to improve both the endurance and retention of 4DS Interface Switching ReRAM cells. Access to the write circuitry of the megabit memory array remains critical to achieve these goals.

Alternatives to the etch process will be explored in parallel, as the probability of a successful optimization of the etch process is unknown. Additional improvements to the memory cell that were demonstrated on wafers processed at the Stanford Nanofabrication Facility will be incorporated in this next Platform Lot, as well.

On 23 November 2022 the Company announced the granting of its 33rd USA patent and advised that there is one patent application pending.

On 2 December 2022 4DS was informed that it would be removed from the S&P/ASX All Technology Index effective on 19 December 2022.

On 7 December 2022 4DS announced it had finalised the terms of the 2023 collaboration extension with imec which will run until mid-2023. Please review that announcement for more detail.

On 19 December a 2023 Board and Management Incentive Plan was announced. Please review that announcement for more detail. The Company prepared a Notice of Meeting to have Director options approved by Shareholders and this was lodged on 19 January 2023 with the meeting scheduled for 20 February 2023.

Financial Review

As of 31 December 2022, the Company held cash of \$3.359 million, compared to \$4.322 million as of 30 September 2022. Net cash of \$0.921 million was used in operating activities during the quarter, a reduction of \$45k when compared to \$0.966 million used in the September quarter. The main difference, when compared to the previous quarter, was a reduction in R&D expenditures offset by an increase in staff and remuneration costs (some of which had been deferred in the September 2022 quarter).

In item 6 of the Appendix 4C cash flow report for the quarter, payments to related parties of approximately \$188k represent salaries paid to the Executive Chairman, the Executive Director and Director fees paid to the Non-Executive Directors. These payments include payment on 16 November 2022 of the 3 months' worth of deferred compensation mentioned in the 16 August 2022 Company Update.
