Limited. On 1 July 2022, additional principal was extended to the Company of \$1,500,000 taking the total principal available under this facility to \$6,000,000. All other terms remained the same with the exception of the expiry date that through negotiation by the Company during the quarter was able to be extended to 31 December 2025. <p>The terms of the loan are:</p> <ul style="list-style-type: none"> Principal loan available is \$AU6,000,000; Loan agreement date is 21 June 2018, second loan agreement signed on 1 July 2022 for a further \$1,500,000; The interest rate is 5% per annum; Interest is accrued and applied to the principal; Maturity/expiry date of loan agreement: 31 December 2025. <p>The Company worked with both lenders during the period and was able to successfully extend both the Convertible Loan Facility Agreement and Shanghai Long Sheng Technology loan to have a maturity/expiration date of 31 December 2025.</p>
