# Summary of the Key Terms of the Employment Contract between ActivePort Group Ltd and Kathryn Soares

#### 1. Commencement Date

Kathryn Soares will commence employment in the position of Head of Global Partners of ActivePort Group Ltd on 3<sup>rd</sup> April 2023 pursuant to an Employment Contract. Mr Soares' appointment is ongoing with no fixed term.

#### 2. Remuneration

Ms Soares will receive an annual total fixed remuneration comprising salary of \$170,000 plus superannuation contributions in accordance with all relevant legislation.

Short Term Incentive Ms Soares may be eligible for a performance based bonus up to a maximum value of \$20,000 (10% of total fixed remuneration) in either cash or shares. The actual amount she will receive will be subject to achievement of key performance indicators determined by the Board.

### 3. Termination

Either party may terminate Ms Soares employment contract at any time on one months' notice. Ms Soares' employment may also be terminated by ActivePort summarily without notice for serious misconduct and in other defined events.
