### Entitlement Offer - Despatch of Prospectus

Metarock Group Limited (ASX code: MYE) (**Metarock** or the **Company**) advises that the Prospectus dated 12 May 2023 (**Prospectus**) and Entitlement and Acceptance Forms for Metarock's pro rata non-renounceable entitlement offer (the **Entitlement Offer**) were despatched to Eligible Shareholders today.

This announcement follows Metarock's announcement to the market on 12 May 2023 of the launch of the Entitlement Offer being conducted to raise up to A\$3.9 million.

The Entitlement Offer is a non-renounceable pro rata offer of 1 new fully paid ordinary share (**New Shares**) in MYE for every 5.2 shares held as at 7:00pm (Sydney time) on 17 May 2023 (**Record Date**) at an offer price of \$0.15 per New Share together with 1 new option (**New Options**) for every 3.25 New Shares issued, with an exercise price of \$0.23.

The Entitlement Offer opens today and closes at 5:00pm (Sydney time) on Wednesday 7 June 2023.

Details of the Entitlement Offer are contained in the Prospectus released to ASX on 12 May 2021.

Applications under the Entitlement Offer may only be made by following the instructions in the Prospectus and accompanying Entitlement and Acceptance Form. Shareholders should consider the Prospectus in full before deciding whether to participate in the Entitlement Offer.
