On 23 February 2023 Qantas announced its intention to target a buy-back of up to \$500 million of its ordinary shares. On 23 May 2023 Qantas announced its intention to extend the buy-back amount by up to an additional \$100 million. Qantas may, at its discretion, vary the size of the buy-back subject to certain legal restrictions. Qantas also retains the discretion to purchase a lesser value of shares than indicated or no shares at all.
